- (b) The application as contemplated in paragraph (a) shall be accompanied by plans and specifications which clearly illustrate appliances and processes employed and the location of the plant and appliances.
2. The registration certificate shall be in the form as prescribed in the Second Schedule to these regulations.
  3. The provisional registration certificate shall be in the form as prescribed in the Third Schedule to these regulations.
