## **Appropriation Act 13 of 2000**

(GG 2375)

came into force on date of publication: 17 July 2000

### **ACT**

**To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 2001.**

*(Signed by the President on 5 July 2000)*

---

**BE IT ENACTED** by the Parliament of the Republic of Namibia, as follows:-

#### **Appropriation of amounts of money for financial requirements of the State**

1. Subject to the provisions of the State Finance Act, 1991 (Act No. 31 of 1991), there are hereby appropriated for the financial requirements of the State during the financial year ending 31 March 2001, as a charge to the State Revenue Fund, the amounts of money shown in the Schedule.

#### **Short title**

2. This Act shall be called the Appropriation Act, 2000.
