APPLICATION AND A PROPOSAL THAT A PORTION OF FARM ROAD 1717 BE DEVIATED, A PORTION OF FARM ROAD 1717 BE CLOSED AND THAT A ROAD BE DECLARED A PROCLAIMED PORTION OF FARM ROAD (NUMBER 1717): DISTRICT OF GOBABIS: OMAHEKE REGION

It is hereby made known -

- (a) in terms of section 16(3) of the Roads Ordinance, 1972 (Ordinance No. 17 of 1972), that application has been made to the Chairperson of the Roads Board of Omaheke that a portion of farm road 1717 described in paragraph (a) of Schedule 1 and shown on sketch-map P2018 by the symbols A-B, be deviated from the route so described and shown, to the route described in paragraph (b) of Schedule 1 and shown on sketch-map P2018 by the symbols D-C;
- (b) in terms of section 20(1) of the said Ordinance the Permanent Secretary: Works, Transport and Communication proposes that, in the district of Gobabis -
 - (i) that a portion of farm road 1717 described in Schedule II and shown on sketch-map P2018 by the symbols B-B1-B2-F be closed; and
 - (ii) a portion of farm road 1717 be proclaimed as described in Schedule III and shown on sketch-map P2018 by the symbols C-E-F.

A copy of this notice and the said sketch-map on which the road to which the application and proposal refer and other proclaimed, minor and private roads in the area are shown, shall for the full period of 30 days, mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Roads Superintendents, Gobabis, during normal office hours.

AMENDMENT OF FIRE REGULATIONS

The Council of the Municipality of Windhoek, after consultation with the Minister of Regional and Local Government and Housing in terms of regulations 5(3) and 9(1)(a) of the Fire Brigade Services Ordinance, 1978 (Ordinance 10 of 1978), under that Ordinance and under section 94 of the Local Authorities Act, 1992 (Act No. 23 of 1992) further amends the Regulations promulgated by Government Notice 78 of 1978 as set out in the Schedule.

1. The following regulation 7A is inserted after regulation 7:

"FEES AND CHARGES IN RESPECT OF APPROVED TRAINING INSTITUTION

7(A) The course fees as set out in Annexure IIA to these regulations shall be payable in advance to the council by or on behalf of every person undergoing training at the Windhoek Fire Brigade and Emergency Services Training Institution approved by Government Notice 1 of 1998."
