AMENDMENT OF APPOINTMENT OF COMMISSION OF INQUIRY INTO THE ACTIVITIES, AFFAIRS, MANAGEMENT AND OPERATION OF THE ROADS AUTHORITY, ESTABLISHED BY SECTION 2 OF THE ROADS AUTHORITY ACT, 1999 (ACT NO. 17 OF 1999) AND THE ROAD FUND ADMINISTRATION, ESTABLISHED BY SECTION 2 OF THE ROAD FUND ADMINISTRATION ACT, 1999

Under the powers vested in me by section 1 of the Commissions Act, 1947 (Act No. 8 of 1947), I amend the Regulations contained in the Schedule to Proclamation No. 21 of 31 July 2003, by the addition after regulation 16 thereof, of the following regulation 17:

“17. No -

- (a) Commissioner;
- (b) Secretary to the Commission;

- (c) Staff member; or
- (d) person appointed or designated to perform any task on behalf of the Commission;

shall, during and after the existence of the Commission, be liable in respect of anything done or omitted in good faith in the exercise of power or the performance of a duty conferred by or under the Act or this Regulations, or in respect of anything reflected in any public hearing of the Commission, report, finding, point of view, or recommendation made or expressed in good faith and submitted or made known in terms of the Act or this Regulations.”.
