PROMULGATION OF ACT OF PARLIAMENT

The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

No. 7 of 2005: Appropriation Act, 2005.

Act No. 7, 2005

APPROPRIATION ACT, 2005

ACT

To appropriate amounts of money to meet the financial requirements of the State during the financial year ending on 31 March 2006.

(Signed by the President on 27 July 2005)

BE IT ENACTED by the Parliament of the Republic of Namibia, as follows:-

Appropriation of amounts of money to meet the financial requirements of the State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated as a charge to the State Revenue Fund to meet the financial requirements of the State during the financial year ending on 31 March 2006.

Short title

2. This Act is called the Appropriation Act, 2005.
