2. No such permit shall be issued so as to be valid for a longer period than one year and every such permit shall expire on the 31st day of December in the year for which it is granted.

3. It shall be lawful for the Board to refuse any such permit if, in its opinion:—

- (a) the applicant is of unsuitable character;
- (b) the site or premises in respect of which the permit is sought is unsuitable for the purpose; or
- (c) the issue of the permit is not essential to the requirements of the location.

4. The Board may, in its discretion cancel any permit issued under these regulations, if:—

- (a) the premises in respect of which the permit was issued become unsuitable for the purpose;
- (b) the holder of such permit becomes unsuitable;
- (c) the trade or calling is improperly conducted; or
- (d) unseemly or improper conduct habitually takes place upon the premises.

CHAPTER IV.

GENERAL.

1. Any person convicted of any offence against these regulations for which no penalty is specially provided, shall be liable to a fine not exceeding ten pounds (£10) or in default of payment to imprisonment with or without hard labour for a period not exceeding two months.

APPLICATION OF CERTAIN PROVISIONS IN CHAPTER IV OF PROCLAMATION 15 OF 1928 TO THE AREA OUTSIDE THE POLICE ZONE.

WHEREAS section *twenty-seven* of the Native Administration Proclamation, 1928 (Proclamation 15 of 1928), makes provision that that Proclamation shall commence upon a date to be fixed by the Administrator by notice in the *Gazette* with the proviso that in such notice the Administrator may exclude from application any specified part or provision of the Proclamation which shall thereupon not apply until brought into operation by a further notice in the *Gazette*;

AND WHEREAS according to Government Notice 165, dated the 11th December, 1929, the said Proclamation, save and except Chapter IV, was brought into operation on the 1st day of January, 1930;

AND WHEREAS it is desirable to apply certain provisions in the said Chapter IV to the area north of the Police Zone, referred to hereunder;

NOW THEREFORE it is hereby notified that the Administrator has been pleased, under the powers conferred upon him by the said section *twenty-seven*, to declare and make known that the provisions of sub-section (6) of section *seventeen* and of sub-sections (3) and (9) of section *eighteen* (contained in Chapter IV) of the said Proclamation shall apply in that portion of the territory north of the Police Zone, as defined in the First Schedule to the Prohibited Areas Proclamation, 1928 (Proclamation 26 of 1928), as amended from time to time, and shall be deemed to have come into operation in that area with effect from the 1st day of August, 1950.

The Administrator has been pleased, under and by virtue of the powers in him vested by section *five* of the Post Office Administration Proclamation, 1931 (Proclamation No. 15 of 1931) to approve, with effect from the 1st April, 1954, of the following further amendments made by the Director to the Telephone Regulations published under Government Notice No. 73 appearing in Official Gazette No. 1414 of the 16th March, 1949, as amended by Government Notice No. 180 appearing in Official Gazette No. 1435 of the 1st July, 1949.

2. Geen permit mag uitgereik word met 'n geldingsduur van langer as een jaar nie en elke sodanige permit vervel op 31 Desember van die jaar waarvoor dit toegeken is.

3. Die Raad kan enige sodanige permit weier as, syms insiens:—

- (a) die aansoeker van ongeskikte karakter is;
- (b) die terrein of perseel ten opsigte waarvan die permit aangevra word, daarvoor ongeskik is;
- (c) die toekenning van 'n permit nie noodsaaklik is vir die behoeftes van die lokasie nie.

4. Die Raad kan 'n permit wat ingevolge hierdie regulasie uitgereik is, na goeëdukke intrek, as:—

- (a) die perseel ten opsigte waarvan die permit uitgereik vir die doel ongeskik word;
- (b) die houer van sodanige permit ongeskik word;
- (c) die sakeonderneming of beroep onbehoorlik gedryf of uitgeoefen word;
- (d) daar gewoonlik onbetaamlike of onbehoorlike gedrag op die perseel plaasvind.

HOOFSTUK IV.

ALGEMEEN.

1. Elkeen wat skuldig bevind word weens 'n oortreding van hierdie regulasies waarvoor daar geen straf uitdruklik voorgeskryf is nie, is strafbaar met 'n boete van hoogstens tien pond (£10) of by wanbetaling met gevangenis, met of sonder dwangarbeid van hoogstens twee maande.

TOEPASSING VAN SEKERE BEPALINGS IN HOOFSTUK IV VAN PROKLAMASIE 15 VAN 1928 OP DIE GEBIED BUIITE DIE POLISIESONE.

NADEMAAL artikel *sewe-en-twintig* van die „Natuurle-administrasie-Proklamasie 1928” (Proklamasie 15 van 1928) bepaal dat sodanige Proklamasie in werking tree op 'n dag wat die Administrateur by kennisgewing in die *Offisiële Koerant* vasstel met die voorbehoud dat die Administrateur in sodanige kennisgewing enige bepaalde deel of bepaling van die Proklamasie buite werking kan stel, wat daarna nie van toepassing is nie totdat dit uit hoofde van 'n nadere kennisgewing in die *Offisiële Koerant* in werking gestel word;

EN NADEMAAL bedoelde Proklamasie, ingevolge Goewermentskennisgewing 165 van 11 Desember 1929, op die 1ste dag van Januarie 1930 in werking gestel is met uitsluiting van Hoofstuk IV daarvan;

EN NADEMAAL dit wenslik is om sekere bepalinge in die genoemde Hoofstuk IV, wat hieronder genoem word, op die gebied noord van die Polisiezone toe te pas;

SO IS DIT dat daar hierby kennis gegee word dat dit die Administrateur behaag het om, ingevolge die bevoegdheid hom verleen by genoemde artikel *sewe-en-twintig*, te verklaar en bekend te maak dat die bepalinge van sub-artikel (6) van artikel *sewentien* en van sub-artikels (3) en (9) van artikel *agtien* (wat in Hoofstuk IV voorkom) van die bedoelde Proklamasie van toepassing is op daardie deel van die gebied noord van die Polisiezone wat bepaal word in die eerste bylae van die „Verbode Gebiede Proklamasie 1928” (Proklamasie 26 van 1928), soos van tyd tot tyd gewysig, en hulle word beskou as reeds in werking in daardie gebied met ingang van die eerste dag van Augustus 1950.

It is hereby notified for general information that the Administrator has been pleased, under the powers vested in him by sub-section (9) of section *eighteen* of the Native Administration Proclamation, 1928 (Proclamation No. 15 of 1928), to make the regulations in the Schedule hereto in regard to the administration and distribution of native estates in that portion of the territory north of the Police Zone, as defined in the First Schedule to the Prohibited Areas Proclamation, 1928 (Proclamation 26 of 1928), as amended from time to time, and to declare that these regulations shall be deemed to have come into operation with effect from the first day of August, 1950.

Ter algemene inligting geskied daar hierby kennisgewing dat dit die Administrateur behaag het om, kragtens die bevoegdheid hom verleen by sub-artikel (9) van artikel *agtien* van die „Natuurlike-administrasie-Proklamasie 1928” (Proklamasie 15 van 1928), die regulasies in die bylae hier-van af te kondig ten opsigte van die administrasie en distri-busie van natuurlikeboedels in daardie deel van die gebied noord van die Polisiezone wat in die eerste bylae van die „Verbode Gebiede Proklamasie 1928” (Proklamasie 26 van 1928), soos van tyd tot tyd gewysig, bepaal word, en om te verklaar dat hierdie regulasies reeds van krag beskou moet word met ingang van die eerste dag van Augustus 1950.

REGULATIONS FRAMED UNDER THE PROVISIONS OF SUB-SECTION (9) OF SECTION EIGHTEEN OF THE NATIVE ADMINISTRATION PROCLAMATION, 1928, FOR THE ADMINISTRATION AND DISTRIBUTION OF NATIVE ESTATES IN THAT PORTION OF THE TERRITORY NORTH OF THE POLICE ZONE.

1. In these regulations, unless inconsistent with the context—

“the Proclamation” means the Native Administration Proclamation, 1928;

“estate” means the estate of a deceased native.

2. If a native dies leaving no valid will, his property shall be distributed in the manner following:—

(a) If the deceased, at the time of his death, was—

(i) a partner in a marriage in community of property or under ante-nuptial contract; or

(ii) a widower, widow or divorcee, as the case may be, of a marriage in community of property or under ante-nuptial contract and was not survived by a partner to a customary union entered into subsequent to the dissolution of such marriage, the property shall devolve as if he had been a European.

(b) If the deceased does not fall in a class described in paragraph (a) hereof, the property shall be distributed according to native law and custom.

3. All the property in any estate falling within the purview of paragraph (a) of regulation two shall be administered under the supervision of the Native Commissioner of the district or area in which the deceased ordinarily resided and such Native Commissioner shall give such directions in regard to the distribution thereof as shall seem to him fit and shall take all steps necessary to ensure that the provisions of the Proclamation and of these regulations are complied with.
